How might the SEA and Environmental Report help you respond to the CGSF consultation? The Environmental Report summarises the findings of the environmental assessment and provides information on environmental issues of relevance to the CGSF. The CGSF has a primarily socio-economic agenda. Whilst it will deliver a broad range of environmental benefits, many of its positive impacts will be focused on socio-economic development and regeneration issues. In contrast, the Environmental Report focuses mainly on environmental issues to help people make more environmentally informed decisions.

The Environmental Report includes information on our proposals for making the CGSF's beneficial environmental effect stronger. You may have your own ideas for making the Games' environmental benefit bigger and we would welcome your views on this matter.

Also, information in the Environmental Report on the CGSF's potential adverse environmental effects should help you to make more balanced choices about the benefits of socio-economic development and regeneration over environmental impact. Equally, you may have ideas for delivering the CGSF's socio-economic objectives with no or less environmental impact, over and above those we have already considered. Your comments and suggestions will help us to make a more sustainable plan.
